Graduation requirement: At least half of the credits required for graduation must be taken from a four-year institution. A minimum of 32 upper-division credits (300 level or 400 level) taken at Nevada State College is also required.

Agreement

This document serves as the agreement between students from the College of Southern Nevada (CSN) and Nevada State College (NSC). This agreement is valid under the following terms:

1. The student is guaranteed the use of the agreement's catalog year upon admission at NSC, provided that:
 - a. he/she is a matriculated student or has matriculated at CSN during the academic year of this agreement and,
 - b. the degree program requirements can be completed within ten years from the agreement's catalog year.
2. The student must stay within the curriculum as outlined by this agreement.
3. The student must earn at least the minimum grade point average required for admission into the major at NSC.

Note: NSC reserves the right to evaluate courses that are applied to the major requirements and were taken from institutions outside of the Nevada System of Higher Education (NSHE).
